1. Opening Remarks and karakia

The meeting started with a karakia at 2.03pm

2. Items for Information

2.1 Timeline update

Manager Policy & Implementation presented the Council with an update on the timeline. The Council were advised that Monday 11 July is the proposed date for the new fee and levy to take effect.

2.2 Action list

The CE presented the Council with the action list from the 14 April Fees and Levy hui to satisfy the Council that all required actions had been completed.

The Council were asked whether there was any further information they felt they needed before making final decisions. The Council were satisfied that they had all they needed.

Discussion was had around the feedback received regarding work that falls within the Ministry's and other organisations responsibilities. It was noted that the feedback in general will also be shared with the Minister at the 30 June Governing Council hui.

2.3 Analysis and summary of re-consultation feedback

Manager Policy and Implementation presented the Council with the analysis and summary of feedback received from the profession in the re-consultation. This was in addition to the Council having access to the raw data of survey responses and submissions.

It was noted that while the voting across the three options was relatively even, the proportion of LAT holders to Registered Teachers that responded was small. An overview of the themes of feedback were

presented to the Council with the main message being fairness, however there were varying ideas of what fairness looked like.

Discussion was had around briefing the key stakeholders on any final decisions made on the fee and levy prior to sending information to the profession. A decision was made to send embargoed copies of all final decisions to all key stakeholders and bring everyone together for a meeting.

Action: Invite ALL stakeholders to a meeting at 8am Wednesday 1 June. Action: Send embargoed copy to stakeholders at 7am

3.3 Communications plan and draft comms for final decisions Susan joined at 2.30pm

The CE introduced the comms pack and spoke to the changes since the last Council meeting. The Council were updated on the plan to release the final decisions to the profession, stakeholders and the public. The Council were advised that the Teaching Council plans to proactively release board papers and key decisions to the public to get ahead of the expected OIA requests.

A decision was made to not use the short video format of communication as it may not be well received by the profession.

A discussion was had around what media requests the Council would agree to. The Council felt it was important to be seen as open, transparent and upfront to any questions. It was decided that in general we would respond to media requests but they as always, would be assessed on a case by case basis. Nicola Ngarewa as Chair, was appointed the media spokesperson for this kaupapa.

3. Items for Decision or Approval

3.1 Fees and levy re-consultation - decisions on allocation of additional savings

The Council **agreed** to use some of the additional savings for \$1.501M to reduce the levy imposed on holders of a LAT issued for 3 years.
